Dog training covered under this permit is defined as the handling, exercising, teaching, instructing, and disciplining of dogs in the skills and techniques of hunting and retrieving

game birds characterized by absence of judging, awards, or any fees related to the shooting of game birds.

General Terms of Permits

1. All birds killed must be game bird farm birds obtained from a lawful source and released on the day of training only. Birds may only be killed on the day they are released. All birds not killed become the property of the state.
2. Permittee shall attempt to flush all wild game birds from the training area each day.
3. Game bird farm birds may only be killed by the permittee or persons accompanied by the permittee and assisting in training.
4. All game bird farm birds used for training must have a streamer of fluorescent surveyor tape conspicuously attached prior to release at the training site.
5. Game bird farm birds killed during training shall remain in the possession of the permittee unless the game birds are transferred to a person either in possession of a valid permit listed under ARM 12.6..1602 or in possession of documentation signed by the permittee assigning ownership of the birds.
6. All dog training areas must be more than one mile from any bird nesting or management area or game preserve.
7. This permit does not authorize commercial shoots or organized hunts or the selling, breeding, or propagation of captive reared upland game birds.
8. Trainers utilizing captive reared mallards for dog training must have a bill of sale indicating legal acquisition and possession of the migratory birds. USFWS requires that captive reared mallards over 6 weeks must be banded, toe clipped, or have a wing pinioned.
9. The dog training permit expires on December 31 of the year of issue.
10. Any violation of the terms of this permit may result in permit revocation and/or criminal penalties.
