The meeting of the MHGDC Board of Directors was called to order at 7:05 PM.

President's Report: A draft gun safety policy prepared by Randy was reviewed by the Board. The Board offered several suggestions to the language, and asked Randy to continue to work on it. Randy will have a second draft to present to the Board at the April Board meeting.

Secretary's Report: Minutes were read from the 12/21/04 meeting and approved.

Treasurer's Report: Savings-\$11,830.00, checking - \$5,998.00. FWP meeting room reserved and paid for 2005. Liability insurance premium is coming due in April. Ray is looking at another insurance carrier. Will have a recommendation soon.

Pointers: Fun trial dates: May 7, 1:00 PM (Sat), June 18, 1:00 PM (Sat), July 17, 7:00 AM (Sun), August 28, 7:00 AM (Sun) at training grounds. Secretary's note: after the Board meeting, Pointer Group asked that these dates be revisited before they are finalized.
